

HOME EQUITY LINE OF CREDIT DISCLOSURE

MINIMUM BALANCE REQUIREMENT ADDENDUM

In consideration of National Bank of Southwest Florida absorbing the settlement costs on the first \$100,000.00 of the subject revolving line of credit, borrower(s) agree to fund, during the first year, a minimum balance on the line of fifty per cent (50.00%) of the loan amount for a minimum of 90 consecutive days.

If Borrower(s) does not meet this provision, National Bank of Southwest Florida (Lender) shall charge Borrower(s) a usage penalty of one per cent (1.00%) of the loan amount with a minimum charge of \$200.00.
